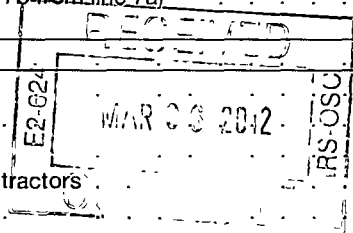

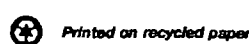

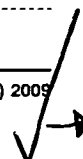

The 2009 financial information submitted on this Form 990-EZ and Schedule A are estimated based upon the activities and events of the organization in 2009. In March 2010, the Board of Directors was made aware that the organization's bank accounts had been depleted by the current Treasurer of the Board of Directors. Those bank accounts were immediately closed, the Board Treasurer released from duty, a new bank account was opened with the cash on hand at that time of \$4,171. After several unsuccessful attempts to secure the financial records of the organization from the previous Treasurer, the Board of Directors began to rebuild the organization financially. As a result of these circumstances, the Aldersgate Emmaus, Inc. Board of Directors implemented some financial and internal controls in order to prevent any type of recurrence in the future (see attached copy of Resolution that was implemented in 2010).

Whereas Aldersgate Emmaus, Inc. Is governed by the Board of Directors.

Whereas Aldersgate Emmaus, Inc. Receives and disburses monies.

Whereas Aldersgate Emmaus, Inc. Maintains bank accounts and other assets.

Whereas Aldersgate Emmaus, Inc. Duly elects a member of the Board of Directors to serve as Treasurer.

Whereas Aldersgate Emmaus, Inc. Treasurer shall receive, deposit, and disburse monies.

Whereas Aldersgate Emmaus, Inc. Shall appoint two (3) members of the Board of Directors to review all disbursements and cause two (2) to sign all disbursement checks.

Whereas the Chrysalis Community serves under the corporate structure of Aldersgate Emmaus, Inc.

The Board of Directors resolves to receive, deposit, maintain, and disburse funds and other assets of both Emmaus and Chrysalis Communities as follows:

The Aldersgate Emmaus, Inc. Treasurer is hereby granted authority to:

Serve as an Officer and Registered Agent of the Corporation.

Serve both the Emmaus and Chrysalis Communities.

Open and maintain Checking Accounts, as deemed necessary by the Board, in the name of Aldersgate Emmaus, Inc.:

At a Federal and State of Florida chartered bank and located in the State of Florida.
May select such bank branch convenient to the Treasurers' location.

Receive and account for all receipts and disbursements.

Maintain records in accordance with General Accepted Accounting Principles in as much as is practical

Prepare records and checks for disbursements and submit to the appointed signatories for signing.

Prepare bi-monthly and annual balance sheets and profit and loss statements

Such records and statements shall reflect all receipts, holdings, disbursements including but not limited to outstanding debts and payables.

Maintain records of other assets to wit: Storage Trailer, Weekend Supplies, and Equipment.

Prepare and submit State and Federal reports pertaining to the corporation non-profit status.

Prepare and maintain corporation Sales Tax Exempt status.

Maintain communication with the Florida United Methodist Conference and its Insurance Broker to continue Director's & Officer's Liability Insurance and General Liability Insurance.

The Board of Directors shall cause an annual end of each calendar year an audit of the financial status to be accomplished by an independent auditor chosen by the Board of Directors.
