Florida Advocacy and Education Program- CCC is spearheading efforts to reform coastal management policies in Florida in order to better protect the state's globally important sea turtle nesting beaches. The focus of this effort is on preventing coastal armoring, protecting nearshore foraging and developmental habitats, serving on advisory committees, and creating partnerships with other stakeholders. Along with policy initiatives, CCC conducts educational programming to raise awareness about threats to sea turtles and actions people can take to reduce impacts on turtles and their habitats. Specific efforts are made to raise awareness about lighting impacts to turtles and to promote beach-friendly practices by residents and tourists. CCC also hosts Tour de Turtles, an annual

Costa Rica Sea Turtle Research and Conservation Program- CCC is known for its sea turtle monitoring and protection program at Tortuguero, Costa Rica. Begun in the mid-1950s, this program is now the longest running conservation program of its kind in the world. Every year, between March and December, CCC researchers and volunteers conduct nesting and population monitoring studies at Tortuguero Beach, home to the largest colony of green turtles in the Western Hemisphere. The research takes place out of CCC's biological field station, where researchers and volunteer participants gather each year to monitor and protect the nesting colony. Through this conservation program, CCC has helped increase the green turtle nesting population in Tortuguero by more than 500%.

Barrier Island Center - The Barrier Island Center (BIC) is an educational facility located in the Archie Carr National Wildlife Refuge (the Refuge) in Melbourne, Florida. The Refuge is one of the world's most important sea turtle nesting sites. The BIC is a focal point for the Refuge, providing educational exhibits, a presentation hall, and ongoing educational programs that promote stewardship of the area's coastal resources. Through a partnership with Brevard County, Florida, CCC manages and conducts the educational programs offered at the BIC, including a summer camp, stewardship workshops and various annual events.

Panama Sea Turtle Research and Conservation Program - CCC's most recent project is working to protect and recover the globally-significant hawksbill and leatherback sea turtle nesting populations at Chiriquí Beach, Panama. The program consists of intensive monitoring of hawksbill and leatherback nesting activity, protection of nesting females and their nests, and public education in the region. CCC works in partnership with the indigenous Ngöbe Bugle community to carry out this research and encourage community support for sea turtle protection programs. CCC's research facility also hosts visiting researchers seeking to develop conservation programs based on the indigenous partnership model in their own countries.

International Policy Program - This CCC program is focused on reducing incidental capture of sea turtles in fisheries and promoting international accords for conservation. CCC staff work with governments, regional fisheries, management organizations, fishermen and conservationists to address bycatch policy and promote turtle-friendly regulation in major commercial fisheries. Some of the possible solutions include gear
