


We are a small island with a year round population of about 650. The Community Center is endeavoring to provide programs which promote health, fitness and social interaction. In 2005 we purchased a building which we are renovating and expanding, which became our home during 2010. In the meantime, we have periodic events such as a Harvest Festival or a dance, etc. On our larger events, 100-200 people attend. On smaller programs such as aerobics, only 15-20 could participate due to space limitations.

We operate a Youth Center that is open weekends and some evenings/afternoons. This is in a modest rental space. 10-40 young people participate in social events, crafts, study assistance, and an occasional trip to the mainland for a special event. Our island is only accessible by boat and there is no other facility (other than the school) on the island for teenagers.
