For over twenty years Louisville Third Century produced Strassenfest, Kentuckiana's third largest summer festival entertaining over 225,000 visitors and growing to include two new events Artsfest and Celebrate! On the Waterfront Following two consecutive catastrophic years (due to weather), the festivals were put on hiatus until all debt was paid off and pre-event underwriting could insure a reasonable expectation of its success as a fundraiser Remounting this enterprise is a huge undertaking, a process, not just a statement of "we're back, and this is what we're doing" L3C staff worked to reestablish relationships with vendors, sponsors, and civic associations such as Louisville Downtown Management District (formerly LCA), the Convention and Visitors Bureau, Main Street Business Association, and The Waterfront Development Corporation to name a few Most interestingly though our discussions with local government personnel led to a "eureka" moment between the Special Events department of the Office of the Mayor, the Office for International Affairs, and L3C staff the problems facing all could be best suited by a collaborative effort So, at the invitation of the City Louisville, Third Century agreed to suspend its immediate plans to resurrect the full blown Strassenfest and to lend our festival expertise to the expansion of WorldFest In essence they provided the venue and event and we provided our considerable knowledge in operations, entertainment, food and beverage, advertising, sponsor relations, and volunteer staffing Additionally our Strassenfest styled "beergarten" served as the anchor (and oasis) for the expansion of the festival over the entire Belvedere complex and its RiverWalk connector Our involvement with WorldFest was much more significant with two days of free to the public entertainment We also worked with the CItY of Louisville and the Us Office of Immigration and Naturalizationto host a reception for over 150 newly naturalized citizens

Jefferson County Public Schools have been a beneficiary of Louisville Third Century since the early 1990s Our Job Shadowing and the Student High5 Achievement programs have been great successes and have served as national models for similar projects in school districts from Baltimore to Kansas City In early summer of 2007 the Education Committee recommended that the board inaugurate a SmartBoards for SmartKids program In essence SmartBoards are computerized, interactive electronic chalk boards linked to student handheld "clickers" and a teacher’s laptop When installed in the classroom teachers have a state of the art tool for accessing educational materials on virtually any subject at any grade level The "clickers" allow individual students' work to be tracked in real time lending greater insight into how each student is approaching their work Teachers can then design plans and exercises aimed at individual students' specific needs In 2008 the Campaign was renamed SmartBoards Make SmartKids By the end of 2008 four systems were installed at Indian Trails and Breckenridge-Franklin Elementary schools This is, and will be, a long term program, seeded by these placements and hopefully branching out through matching and challenging programs to increase the rate of systems installed Third Century has also begun the publication and sale of a "celebrnty" community cookbook the proceeds of which will underwrite this program

Much has been recorded concerning the rescue of the Louisville Orchestra from the brink of bankruptcy Obviously our organization did not, nor would not be able to completely meet their financial needs but we did offer to act as a catalyst to help them increase their fundraising receipts Since their initial contact Louisville Third Century Board members, staff and volunteers have donated approximately 2,000 hours of their time to help the Orchestra to help themselves In fact one Third Century member has been taken on by the Louisville Orchestra as a part-time employee The Orchestra will never stop needing money Third Century remains committed to the welfare of the Orchestra and its role in our community Our efforts on their behalf are truly in keeping with our mission to act as a catalyst to improve the quality of life for the people of Jefferson County We would be remiss if we didn't include some mention of a developing seed, an off shoot of our Strassenfest plans, that is the evolution of traditional Bach & Brunch into a multidisciplinary production of a "Fusion of the Arts" program/special event employing dance, visual and design arts, music, and the culinary arts as a fundraiser for the Orchestra and Ballet (i.e , underwrite the ballet's use of orchestra for its productions) This obviously is a work in progress that will cover a two year (or more) timeframe

Literally every year the Louisville Ballet would approach Louisville Third Century requesting financial support And in many instances we obliged, cut a check and that was that But with our funds short due to the absence of festival revenues L3C realized we needed a new approach to supporting local arts groups we no longer just cut a check, we "taught them to fish" As noted above we began with the Louisville Orchestra and have now offered the same opportunity to the Louisville Ballet, (Kentucky Dance Council) Over the last half of 2008 Louisville Third Century staffers and volunteers spent hundreds of hours in meetings and training sessions and gaming sessions teaching the Board and staff of the Ballet how to execute successful gaming operations (It should be noted that Ballet already had a gaming license but they had not realized its potential, mostly due to "personnel" issues) Though in its infancy, and realized by all involved as only "one aspect" of a over all solvency plan, this campaign has kept the wolf from the door and allowed them to keep their operations running even in the face of managerial turnover and severe cut backs in their traditional funding This too is an ongoing process, but one that is delivering meaningful financial assistance In 2009 Louisville Third Century also joined with the Kentucky Opera
