Social Responsibility

The YMCA provides outreach programs for children living in low-income housing through a collaboration with the Hopkinsville Housing Authority and Martin Luther King Jr. Elementary. We provide after-school tutoring, drug education, and offer computer lab time with certified teachers. The program is year round and we offer a summer camp program with educational and recreational activities. Also, in partnership with the Juvenile Justice Center, we offer "Girls Night Out" and "Warrior Knights" for teenage girls and boys which centers on teen issues and struggles.

The YMCA offers the "Jobs for Life" program which teaches job skills to those who are unemployed or under-employed to obtain and keep meaningful employment. Participants are in the low income bracket and classes are held in surrounding neighborhoods. Jobs for Life training topics include: Understanding value and purpose, attitude, integrity, excellence, respect for authority, interviewing skills, conflict resolution, career objective and vocational plan, taking responsibility, building a resume, perseverance, employer expectations, overcoming fear, customer satisfaction and communication.

Each session include eight classes which last two hours per class. The classes are free to participants and the YMCA provides all books, snacks, two meals and all graduation expenses. In 2009, eight classes were held with 71 participants and 53 graduates.

The YMCA also provides a program at Means Avenue Baptist which is located across the street from Pennyriple Homes Section 8 Housing. The youth come over for activites, recreation, and computer activites during the year. The church is used when we have gaps in our school program at MLK and Summer Camp. These times include school breaks such as Spring Break, Fall and Christmas Break, and days surrounding summer camp. Our goal is to offer year round care to keep children engaged in positive activites and to keep them out of trouble.

We served over 83 children and taens in 2009.
