Community Building during 2009 we completed the facilitated process of community initiated decision making that included surveying more than 200 individuals, hosting numerous focus groups across diverse sectors, and four community town hall meetings culminating in a community wide strategic framework that we will use to guide our fundraising and grantmaking in the coming years. The five areas the community has chosen to focus on are Education, Arts, culture, and recreation, Housing and family assets, Environment, and Health and wellbeing. We completed a comprehensive detailed plan which is available to the public. Capacity Building in order to establish the infrastructure required for an open and accessible community foundation, we opened an office in the county and obtained outside resources to support administrative functions so we could begin a community campaign that would build our unrestricted endowment fund. We published four newsletters that went out to a mailing list of 900 residents, created a website, engaged an outside CPA firm to perform bookkeeping tasks and solicited donated office furniture and equipment. The office is open to the public 5 days a week. Endowment Building in 2009 we used our newsletter and several public forums to inform people across sectors in the community about the endowment for Hazard and Perry County. Through speaking engagements with civic clubs, schools, and other community events, we began to let people know about the opportunity to make contributions no matter how small, to a permanent unrestricted endowment for the community. We increased the number of donors from 2 to 48 and that number continues to grow.
