The Princeton Closet either resells donated clothing and household goods or donates these items to other organizations for the needy. In 2009 \$110,500 of these receipts were donated to area charitable organizations, other 501(c)(3) organizations, church related organizations and government sponsored programs. Donated clothing, household items and toys are also given at no cost to families and individuals who have suffered from a disaster such as a fire. These people are usually referred to us from local government agencies, American Red Cross and churches. Two families were assisted in this manner during 2009. Excess donated clothing, shoes and household items are either given to the needy or are eventually sent overseas and distributed to countries in need of clothing items, etc. It is estimated that 6,200 bags of clothing was shipped overseas in 2009. The Princeton Closet has approximately 78 people who volunteer their time on a regular basis to assist in the Closet's mission. These people donated approximately 14,844 hours of their time to the Closet in 2009. Other volunteers work at the Closet to fulfill their required community involvement requirements. The local high school mandates all students must volunteer a certain amount of time prior to graduation. (CONTINUED ON SCHEDULE O)
