Since launching the program in February 2007, 36 productions have completed principal photography including 17 features, 4 Movies of the Week and 15 commercials. These productions have collectively spent over \$33 million in communities all across Washington State, while receiving \$7.2 million in financial incentives. This return on investment represents real economic development for the state of Washington. Washingtonfilmworks added the Viral Video Campaign during 2009 to commission up to five Washington filmmakers to create 30 and 60 second commercial spots promoting Washington state as a great place for motion picture, commercial, and television production.
