EXPLANATION: In November 1986, WBC was given a rundown house in a declining neighborhood to provide a place for Bible clubs and storage of camp equipment and supplies. This was recorded in Deed Book 1003, Page 900, at the Probate Office, Jefferson County, Alabama. The County's first property valuation was signed on 7/15/88 and it showed the market value as \$9,790.00, comprised of \$4250 for the value of the land and \$5,540 for the house. Book Value of land does not increase or depreciate, but the house value is depreciated using 27.5 years, per IRS rules for residential rental buildings. During 1997-2002, extra funds had to be kept on hand for essential repairs made by volunteer help to make the building more usable. Windows, siding, plumbing and electrical were repaired or replaced and materials were expensed when paid.
