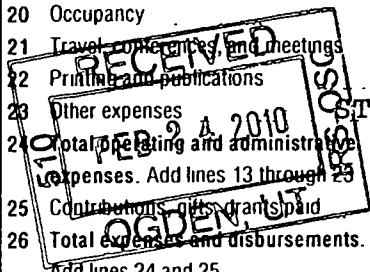

The purposes for which the Foundation are created are: first, for the investment of the capital by the said Board of Trustees, and second, for the collection of the income therefrom, and third, for the distribution of the income therefrom for charitable purposes, as follows, to wit:

For the benefit of the indigent sick, in payment of expenses for medical, surgical and hospital attention and services other than doctors' bills or surgical fees. The purpose is to pay for the medicine and hospitalization and medical and surgical supplies, and other needed necessary benefits for the indigent sick, and for their sustenance during the time of illness and treatment.

These benefits shall be distributed to worthy cases of the indigent sick who have no other sufficient course of relief and the benefits herein are primarily for citizens of Lowndes County, Mississippi.
