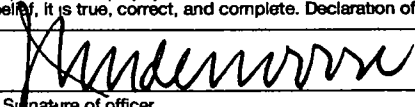

The sole purpose of The Hundred Club of Jackson is to support the Police and Fire Departments of the City of Jackson, Mississippi and the Sheriff's Department of Hinds County, Mississippi.
