

I do not believe Schedule N was required by this transfer but we have included it just to ensure a complete return.

This transfer did not involve 25% of our assets nor did we go out of business. In March 2007 Pine Island FISH agreed to assume management of the Pine Island Food Pantry which had been operating under the auspices of the local Catholic Church. This was done on a trial basis and was fully within the scope of the FISH Articles of Incorporation. For the tax years 2007 and 2008 the Pine Island FISH tax submission included numbers for both FISH and the Pantry. However, since it was a trial merger, the Pantry bank account was kept separate; there was never any mingling of the funds. In December of 2008 the merger was reviewed by the FISH Board of Directors and it was agreed that no benefits had accrued to either organization nor to our clients.
