	In keeping with our mission, Senior Care Communities has made a significant investment in real estate with the capacity to house the elderly including The Woodbury Senior Living Campus, Woodbury, Minnesota which includes Woodbury Villa, a 75 Unit independent and assisted living facility, Woodbury Estates, a 64 unit assisted living facility, and Woodbury Health Care Center, a 207 bed licensed nursing with a 22 bed affordable assisted living unit. In 2009, Woodbury Healthcare Center provided care for an average of 199 residents per day with approximately 60% of the population being low income as defined by their enrollment in the Minnesota Medical Assistance program. The 25 bed Transitional Care Unit (TCU) which focuses on higher acuity residents requiring intensive rehabilitation services averaged 23 residents per day. The services that residents receive in the TCU help them to return to home or to as independent of a setting as possible. The property also has approximately one third of their beds dedicated to a memory care unit. Woodbury Villa housed and provided services to approximately 73 residents per day in 2009 with an estimated 52% of the tenants being low income. Woodbury Estates housed and provided services to approximately 61 tenants a day. Birchwood Senior living Campus, Forest Lake, Minnesota, which includes Birchwood Arbors, a 46 unit assisted living facility and Birchwood Health Care Center, a 135 bed skilled nursing facility. In 2009, Birchwood Healthcare Center cared for an average of 114 residents per day with over 60% of that population being low income. The property has a 20 bed rehabilitation unit and a 32 bed memory care unit. Birchwood Arbors housed and provided services to approximately 45 residents per day with an estimated 49% being low income. Providence Place, Minneapolis, Minnesota is a 211 bed skilled nursing facility. In 2009 Providence Place provided care for an average of 199 residents per day with approximately 68% of the population being low income. The 35 bed Transitional Care Unit (TCU) which focuses on higher acuity residents requiring intensive rehabilitation services averaged 32 residents per day. The services that residents receive in the TCU help them to return to home or to as independent of a setting as possible. The property also has two units dedicated to memory care, with one of the units being an all female unit. The Colony of Eden Prairie, is a 142 unit independent and assisted living facility with a 25 bed transitional care unit facility, which is jointly owned with Ebenezer Society, a Minnesota nonprofit corporation and 501C(3) tax-exempt organization. The assisted and independent living facility housed and provided services to 138 residents. In addition to traditional assisted and independent living services, The Colony of Eden Prairie provides both memory care services and a unique care suite setting for their residents. In 2009 Senior Care Communities launched a Wellness initiative that will continue to expand in 2010. The initiative adopts a philosophy of whole-person wellness as defined by a multidimensional wheel which incorporates the physical, social, emotional, intellectual, spiritual, and vocational aspects to each individual's life. Programs will be developed for each community to incorporate all dimensions of wellness for our residents and team members. Examples include strength and balance training, social gatherings, generational sharing activities, worship and various cultural events. Senior Care Communities, Inc has very active and successful volunteer programs at each of their properties. Over 557 individuals donated approximately 10,000 hours of service on an annual basis. Volunteers perform many valuable services for the residents who have entrusted their care to Senior Care Communities, Inc. These individuals lead or assist in many day and evening entertainment activities for the residents. When you visit a property, you will see volunteers playing games with residents, reading to residents, hosting ice cream socials, working in the cafe, singing or playing musical instruments and, taking residents on outings and a host of other fun activities. Volunteers will often escort new residents to the dining room for their first meal in a new setting and to help them become acquainted with other residents. Senior Care Communities, Inc is very appreciative of all the services that volunteers provide. These donated services help to provide residents with a higher level of personalized attention. Senior Care Communities has a commitment to spiritual programming and sees it as an essential element in the overall wellness of the individuals that are cared for in their properties. The Woodbury Senior Living Campus has a full time chaplain on staff and the other properties have volunteer chaplains. Each property has non-denominational services on a weekly basis for the residents. Several churches support the properties with volunteers and programming that help to meet the spiritual needs of the residents. They help escort residents to worship services, lead Bible studies, lead reminiscing groups and assist the chaplains in ministering to the unique individual needs of the residents.
