**Part IX-A, Summary of Direct Charitable Activities**

The Foundation provides tutoring services to students in classes the Foundation adopted at Charles Drew Elementary School in Liberty City, Florida; Frederick Douglas Elementary School in Overtown; Phillis Wheatley Elementary School in Overtown; and Holmes Elementary School in Liberty City. The schools are located in low-income neighborhoods and the tutoring services are available for each of the approximately 313 students within the adopted classes.

Individuals provide the tutoring services for the students at the school and the Foundation pays for the tutoring services on behalf of the students. The fourth through twelfth grade students are also offered the Advancement Via Individual Determination (AVID) program in which students are prepared for college through organizational and study skills. This program is also funded by the Foundation.

None of the students in the adopted classes are family members or a "disqualified person" with respect to the Foundation.

NARRATIVE OF EXEMPT ACTIVITIES

Bayview Foundation was created in January 1999 for the purpose of promoting and fostering the education of under-privileged youth. The Foundation "adopted" the entire first grade class of Charles Drew Elementary School in Liberty City, Florida in February 1999, which was comprised of 96 students. Since "adopting" the original class the Foundation has adopted 4 new classes. The new classes are located at Frederick Douglas Elementary School in Overtown (10/05); Phillis Wheatley Elementary School in Overtown (10/05), and; two classes at Holmes Elementary School in Liberty City (3/06). As a result of the new classes the Foundation now has 313 total students in the program. In addition the Foundation has performed various activities in furtherance of its exempt purposes of fostering the education of the students, including the following:

- Provision of over 300 computers and 4 printers for use in the student's classroom.
- Allow the students to visit the offices of Bayview Financial, LP
- Worked with Miami-Dade Public Schools to develop a comprehensive curriculum for a summer program for the students.
- Promised to provide tuition assistance for up to \$2,500 per year for every member of the first grade class that gains admission to a two or four year accredited college or university.
- Provision of tutoring services for each student.

Much of the Foundation's activity since its inception has been the provision of tutoring services to the students. The Foundation employs a Project Coordinator that arranges for the tutoring services needed by the students. The coordinator places the tutors with the students to meet their educational needs. The three new programs employ full time paraprofessionals working in the classrooms with the students.
