NOVA ScriptsCentral, Inc. provides pharmaceuticals to northern Virginians with limited incomes who lack insurance coverage for pharmaceuticals. A formulary of 350 medications for chronic diseases is available to patients.

Approximately 7,200 prescriptions were filled during 2009, providing approximately 21,600 months of therapy.

The retail value of prescriptions provided during 2009 is approximately \$1,500,000.
