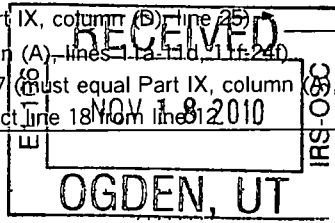

SINCE 1985, THE PROGRAM HAS PROVIDED A SAFE AND SUPPORTIVE HAVEN TO MORE THAN 21,000 DISPLACED WOMEN AND CHILDREN. ST.
