POLICY NO. 32

BOARD POLICY

SUBJECT: CONFLICT OF INTEREST

OBJECTIVE:

It is the policy of PJECC that its directors and employees shall conduct the business of the Cooperative in an honest and ethical manner in order to best serve the interests of PJECC and its members. The purpose of this policy is to set guidelines regarding conflict of interest.

POLICY CONTENT:

PJECC is committed to deterring wrongdoing, improving its ongoing operations and conforming to effective professional and fiscal practices. This policy provides written guidelines designed to promote, among other things, honest and ethical conduct and compliance with applicable governmental laws, rules and regulations. The following examples describe some of the circumstances and conditions that are, might be, or have the potential to be considered inappropriate conduct. These examples are not intended to be all-inclusive.

- (1) Employees and directors are prohibited from receiving gifts, fees, loans or favors from suppliers, contractors, consultants, or financial houses, which are intended to obligate them or induce them to compromise their responsibilities to negotiate, inspect, audit, or award contracts with the best interest of PJECC uppermost in mind. This does not prohibit receiving gifts or favors of nominal value or casual entertainment or reimbursement for business expenses which meet all standards of ethical business conduct and which receipt involves no element of concealment.
- (2) The complete confidentiality of business information must be respected at all times. Employees and directors are prohibited from knowingly disclosing such information to those who do not have a need to know or whose interest may be adverse to PJECC, or in any way using such information for personal gain or to the detriment of PJECC.
- (3) Employees and directors shall make a full and complete disclosure of any personal financial interests that they may have in property that PJECC acquires or considers acquiring, or in a supplier, contractor, consultant, or other entity with which PJECC does business.

POLICY NO.32 CONT'D.

- (4) Employees should get CEO / General Manager approval of any other employment (including contractual / outside consulting). Approval will be denied if a conflict of interest exists or appearance of a conflict of interest exists.
- (5) Employees and directors should not engage in business with the cooperative (such as selling materials or services) unless such business is minor in cost and is not regular in nature. The CEO / General Manager must approve minor and irregular business with the cooperative before the transaction occurs.
- (6) Every director and employee of PJECC is expected to avoid the appearance of conflicts of interest since it is not feasible in a policy statement such as this to describe all the circumstances and conditions that might be, or have the potential of being considered, conflicts of interest.
- (7) These same guidelines apply to close family members and companies / corporations of which the employee or director play a major role.

REPORTING:

Each employee and director must report any situation that violates, may violate, or could appear to violate the intent of this policy to the CEO / General Manager.

INVESTIGATION & ACTION:

The CEO / General Manager will make a good faith determination if the circumstances of the relationship / transaction are a conflict of interest of the operations of PJECC. Some circumstances may warrant further investigation and/or consultation with the Board or legal counsel. If the decision is made that a conflict of interest violation exists, the director or employee will be so advised. A violation may be subject to disciplinary action up to and including termination and/or criminal prosecution.

RESPONSIBILITY:

A. Employee and Director:

Each employee and director shall make every reasonable effort to comply with the letter and spirit of this policy.

Each employee and director shall assist in any investigation concerning a violation of this policy or an investigation by any regulatory or law enforcement agency.

Each employee and director shall report any situation that violates, may violate or could appear to violate the intent of the policy to their supervisor or the CEO / General Manager

B. CEO / General Manager:

POLICY NO. 32 CONT'D.

The CEO / General Manager will investigate allegations of suspected violations of conflict of interest and shall ensure all required procedures are in place to:

- (1) Investigate all violations in a timely manner.
- (2) Document the receipt, retention and disposition of all violations.
- (3) Ensure confidentiality and anonymity.
- (4) Prevent retaliation.
- (5) Review claims of retaliation.
- (6) Ensure independent review by unbiased party.
- (7) Protect rights of "Whistleblower" in accordance with Whistleblower policy.

C. Board President:

In those instances where the CEO / General Manager is implicated in the allegation, the Board President will investigate.

D. Directors, officers and key employees:

Directors, officers, and key employees must complete a questionnaire supplied by PJECC's accounting staff for completion of the corporations' Form 990 to comply with IRS requirements on related party transactions, etc.
