

Gilgit Eye Hospital - Treated patients with eye problems from injuries, disease, and cataracts by surgical or medical means. In 2009, 11,164 patients were seen and 810 surgeries were performed.

Gilgit Education & Rehabilitation Ctr - Provided support for school for blind students. Four teachers continue on staff. Enrollment was 18 students. Through community-based programs an additional 140 children were assisted.

Burma Medical Assistance Program - Conducted medical relief camps and clinics in local villages. In charge of training and equipping medics for 50 Free Burma Ranger teams that serve internally displaced persons. Fifty new Karen community health workers were trained. Opened a new medical school in 2009. Worked on data collection and mapping of internally displaced person groups.
