THE ARKANSAS BROADCASTERS ASSOCIATION HAS LONG MAINTAINED A NONCOMMERCIAL SUSTAINING ANNOUNCEMENT PROGRAM. UNDER THIS PROGRAM, MEMBER AND NONMEMBER RADIO AND TELEVISION STATIONS IN THE STATE VOLUNTARILY DONATE AIR TIME THAT IS MADE AVAILABLE, THROUGH THE STATE ASSOCIATION, TO GOVERNMENTAL AND TO NOT-FOR-PROFIT ORGANIZATIONS FOR THE AIRING OF THEIR MESSAGES. THOSE NCSA SPONSOR'S ANNOUNCEMENTS GENERALLY AFFORD STATEWIDE COVERAGE OF NCSA SPONSOR'S ACTIVITIES, EVENTS, AND PROGRAMS WHICH BENEFIT THE PUBLIC AT LARGE. THE NCSA PROGRAM IS A MAJOR BENEFIT TO THESE GOVERNMENTAL AND NOT-FOR-PROFIT NCSA SPONSORS BECAUSE THE MONEY PAID BY THEM REPRESENTS BUT A FRACTION OF THE FAIR MARKET VALUE OF THE ANNOUNCEMENTS IF THEY HAD BEEN PURCHASED FROM STATIONS. MONEY RECEIVED FROM THE NCSA SPONSORS GOES DIRECTLY TO THE STATE ASSOCIATION AND IS USED BY THE STATE ASSOCIATION FOR ITS TAX EXEMPT PURPOSES, INCLUDING FOSTERING BETTER RELATIONS BETWEEN THE BROADCAST INDUSTRY AND GOVERNMENTAL ENTITIES AND NONPROFIT ORGANIZATIONS, AS WELL AS TO ADVANCE AND STRENGTHEN THE BROADCAST INDUSTRY GENERALLY. ON AVERAGE, A TOTAL OF 176 OUT OF 233 R STATIONS AND A TOTAL OF 21 OUT OF 22 TELEVISION STATIONS THROUGHOUT ARKANSAS PARTICIPATE ON A YEARLY BASIS.
