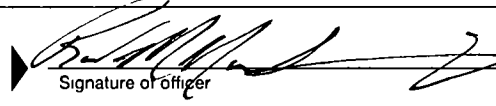

\$225 – Grant to assist the YWCA to offer additional activities in the after school program. The funds were used for fundraising activity expenses, rent of location, event advertisement, food, activities and supplies.

Part V Line 35

The gross revenue reported on Part I Line 6a comes from the sale of chances. This activity is not substantially related to the performance by the organization of its exempt purpose except that the organization uses the profits derived from the activity to carry out the mission of the organization. The income from this activity was not reported on Form 990-T since it occurs once a year and is not regularly carried on.
