Several educational film projects were underway in 2009:

- "Land Of Opportunity," a documentary about housing issues in post-Katrina New Orleans, was in production and post-production
- "Listen Up," a radio documentary produced by Youth Radio, was distributed via radio and podcast
- "Shalom Y'All," about Jews in the South, which was completed in 2002, continued to be distributed on DVD
- "Stories From The Faubourg Treme," about one of America's oldest black neighborhoods, was distributed on DVD and was broadcast nationally on PBS and had film fest showings
- "Desire," produced by the Teenage Girls Documentary project, about growing up as a teenage girl in New Orleans, continued to be distributed to colleges and high schools via an educational film distributor
- "By Invitation Only" (formerly titled "Queen For A Day"), about the southern debutante culture, had broadcasts on many PBS stations and continued educational distribution on DVD
- "Bury The Hatchet," a documentary about Mardi Gras Indians, was in post-production

- "Vows Of Silence," a documentary about a priest who has been accused of sexually abusing seminarians, was distributed via film festivals and on DVD
- "The Music's Gonna Get You Through" (formerly entitled "See What I'm Saying"), a documentary on Henry Butler (a blind pianist, who teaches blind musicians in a summer program at the University of New Orleans TRAC center) and the lives of several blind teenagers over several years, continued in post-production
- The Human Rights Film Festival, a festival exhibiting films on worldwide human rights issues, occurred in the spring
- "Sons of Tennessee Williams," a documentary on gay civil rights history and issues, in New Orleans, was in production and post-production
- "Walker Percy: A Documentary," a documentary film about the writer Walker Percy, was in post-production
- "Murder Through The Eyes of a Child," a documentary on the violence that some children in New Orleans encounter, was in production
- A major restoration effort was underway, to save and restore a documentary produced in the 1980s called "Piano Players Rarely Ever Play Together," about several famous New Orleans piano players. Work toward re-releasing the restored version continued.
- "Race: The 2006 New Orleans Mayoral Election," a documentary on the election just after Hurricane Katrina, was in post-production.
- Development work also continued on other projects, destined to be seen by many thousands of viewers and underserved audiences via film festivals, PBS, cable television, and other outlets in 2009 and beyond.
- Total grants made to these educational film projects were \$ 93,797.07 in 2009
