In 2009, the White Center CDA achieved many outcomes for the White Center community in the areas of family development, neighborhood revitalization and community building. Through our partners and activities, 783 adults were placed into jobs, 539 households created and built savings accounts, 457 children experienced quality preschool, 58% of children were assessed at kindergarten readiness, 50 small businesses were provided technical assistance and 314 residents served in leadership positions at community organizations. In addition, the organization successfully held 3 signature community events with over 400 participants in each: White Center Spring Clean, White Center Community Summit and the annual fundraising dinner. Lastly, a new pedestrian foot bridge was created at White Center Heights Park, as well as the launch of a new White Center Fresh Marketplace Initiative in our business district.
