TO SUPPORT THE PROVISION OF LEGAL SERVICES TO LOW INCOME IOWANS THROUGH CONTRIBUTIONS TO IOWA LEGAL AID, ITS PRIMARY CHARITY, AND TO SUCH OTHER SECONDARY CHARITIES THAT THE BOARD OF DIRECTORS OF THE FOUNDATION SHALL DETERMINE
