	GOODWILL INDUSTRIES OF TULSA PROVIDES WORK OPPORTUNITIES, JOB TRAINING AND SUPPORT SERVICES FOR PEOPLE WITH DISABILITIES OR OTHER EMPLOYMENT BARRIERS. GOODWILL HAS PROVIDED SERVICES TO THOSE IN NEED FOR MORE THAN EIGHTY YEARS AND THE NUMBER OF INDIVIDUALS SERVED BY GOODWILL CONTINUES TO GROW. IN 2009 GOODWILL SERVED OVER 2100 PEOPLE IN OUR VARIOUS PROGRAMS. THE INFORMATION BELOW HIGHLIGHTS THE SERVICES PROVIDED TO THE COMMUNITY BY GOODWILL DURING 2009. WORK OPPORTUNITIES FOR PEOPLE WITH DISABILITIES OR OTHER EMPLOYMENT BARRIERS AT GOODWILL INDUSTRIES OF TULSA INCLUDES POSITIONS INVOLVED IN COLLECTING, PROCESSING AND SELLING GOODS DONATED BY THE PUBLIC IN OUR THRIFT STORES, AS WELL AS CUSTODIAL CONTRACTS, PACKAGING AND ASSEMBLY CONTRACTS FOR LOCAL BUSINESSES AND PLACEMENTS IN TEMPORARY STAFFING ASSIGNMENTS. DURING 2009, MORE THAN 725 INDIVIDUALS WITH BARRIERS TO EMPLOYMENT WERE EMPLOYED BY GOODWILL AND EARNED WAGES AND BENEFITS IN EXCESS OF \$9.6 MILLION. GOODWILL ALSO PROVIDES WORKFORCE DEVELOPMENT SERVICES FOR PEOPLE WITH DISABILITIES AND OTHER EMPLOYMENT BARRIERS WHO ARE SEEKING EMPLOYMENT IN THE COMMUNITY. A BROAD RANGE OF JOB TRAINING PROGRAMS IS AVAILABLE TO PROVIDE THE SKILLS NECESSARY TO SUCCEED IN THE WORKPLACE. THESE SKILLS ARE SUPPLEMENTED BY JOB ASSESSMENTS, CASE MANAGEMENT, JOB PLACEMENT ASSISTANCE AND APPROPRIATE FOLLOW UP AFTER EMPLOYMENT. DURING 2009, MORE THAN 1,580 INDIVIDUALS WERE SERVED IN GOODWILL'S WORKFORCE DEVELOPMENT PROGRAMS AND 337 INDIVIDUALS WITH BARRIERS TO EMPLOYMENT WERE PLACED INTO JOBS IN THE COMMUNITY. THESE INDIVIDUALS PLACED INTO COMMUNITY JOBS EARNED MORE THAN \$2.3 MILLION IN WAGES DURING 2009.
