	The Early Childhood Program provides EARLY EDUCATION SERVICES TO INCOME ELIGIBLE CHILDREN CAP's flagship program promotes early childhood education by delivering a comprehensive high-quality school readiness curriculum addressing the educational, nutritional, health, social, and emotional needs of low-income children ages birth to five As the primary Head Start grantee for Tulsa County, CAP presently operates over 130 classrooms at 18 different sites strategically located throughout the City of Tulsa and surrounding communities In 2009 we served more than 1,900 children ages birth to five, nearly all of which are from families living at or below the federal poverty line By combining best practices in early childhood education and collaborative partnerships with area school districts, social service agencies, and healthcare practitioners, CAP offers a range of services targeted to children and their families These services include parental education, crisis intervention, counseling, medical and dental care, nutrition assistance, and instruction to children with special needs Our program has been identified by the U S Department of Health and Human Services as one of the most innovative in the country, and the majority of our preschool centers have achieved accreditation from the highly-regarded National Association for Education of the Young Child (NAEYC)
