

- 28 Support Local Rainbow Assemblies – statewide membership of approximately 489 young ladies aged between 11 and 20, together with adult volunteers and sponsors of approximately 200, spread across 29 assemblies in the State of Oklahoma. Each local assembly is engaged in service projects conducted in their local community ranging from volunteer and financial assistance to not-for-profit organizations in the community, volunteer assistance at homes for the aged and schools.
- 29 Oklahoma Grand Assembly Session – 3-1/2 day state convention including public speaking competitions, ritual performances, elections for leadership and other programs to promote and develop responsible leadership. Annual attendance of approximately 550 girls and adults each year.
- 30 Leadership Programs – Leadership seminars and programs scheduled during the course of the year. Groups of 200-300 meet 6 times over the course of the year, in addition to the state convention attended by approximately 550 each year. Local assembly officers attend a leadership seminar in March each year, attended by approximately 125 girls, with an adult leadership and training program conducted in February each year attended by approximately 100. The new state officers, approximately 50, attend a training session immediately following their selection each year. Approximately 45 representatives from assemblies spend a day at the state capitol in a mock legislative session.
