In June of 2004, the Internal Revenue Service issued a letter to the taxpayer informing them that they were "presumed" to be a private foundation based on the failure of the support test.

The taxpayer responded with a letter explaining in great detail their exempt purpose, by making loans or equity investments to further community development for low to moderate income persons or other underserved demographics. The taxpayer provided extensive detail to support a "facts and circumstances" test that it should remain a "public charity".

To that letter, the taxpayer received a response from the Internal Revenue Service, dated May 26, 2005 (copy attached), which superseded the June 2004 letter, and stated that MetaFund Corporation was in fact a "public charity".
