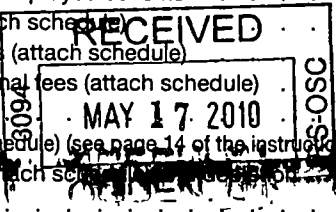

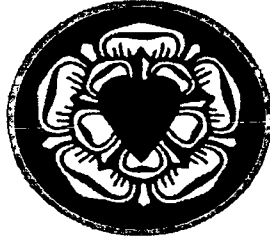

The Allen C. Berndt scholarship grant is available to students graduating from a Lutheran high school of the Lutheran Church - Missouri Synod or in a Recognized Service Organization relationship with the same. One grant will be made available each year in the amount of \$500.00 per school.

The grant is available to students graduating from **Lutheran High School** in Elk Grove, California, **Martin Luther High School** in Northrop, Minnesota and **Sierra Lutheran High School** in Carson City, Nevada. One scholarship will be awarded to eligible students who apply from each school as determined by the board of directors of the Foundation.

If no seniors are eligible in the afore mentioned schools then teachers or principals are eligible to apply for a grant as mentioned below.

The intention of this scholarship is to highlight the need for pastors in the LC-MS and for teachers in Lutheran schools in the same. Any graduating high school senior is eligible to apply for the scholarship, however, with the following requirements.

If there are no graduating students that fit the requirements of entering the pre-seminary program of the LC-MS then any student entering a teacher education program in one of the colleges or universities of the LC-MS with the intention of becoming a teacher in a Lutheran school may apply..

If there are no seniors eligible then individual teachers may apply for a classroom grant of \$500.00.

If no teachers wish to apply then the principal may apply for a school grant of \$500.00.

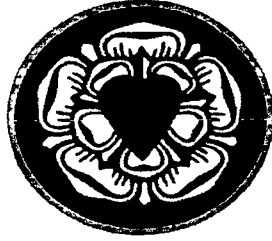
