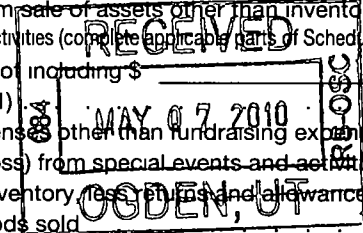



We were gearing up for the spring with the births of many of the animals. These are very popular with kids and adults with the Petting Zoo on the road. Our volunteers were working hard and going through training. Our schedule was filling up especially for the petting zoo. On farm visits, we can do pony rides for those who did not have a physical handicap. This limited our Activity on horseback. We are registered with the county to have physically handicapped individuals participate in our program. The only thing we require is that the individuals sign a pay voucher so the county will pay us \$50 per person per month. This year we had to focus on mentally handicapped individuals.

I. Detail description of activities – Past, Present, Future

a. Farm visits

- i. Activity – The ultimate experience of farm life and hands on experience, this includes Petting Zoo comprised of baby animals (goats, ponies, rabbits, kittens, donkeys, llamas, chickens), Hay ride, Hot dog roast on a open fire, horseback rides, go cart rides, and visiting the adult animals (ducks, cow, turkeys, chickens, goats, sheep, cats, pig, llama, deer, quarter horses, draft horse, donkeys), brushing animals, and feeding animals. This gives the visitors a hands on education experience without worrying about their handicaps since most of our animals have handicaps themselves. The enjoyment and excitement in their faces says it all. It is a way they get to associate with the animals and conquer many of their fears.
- ii. Who conducts this activity – Trustees and volunteers
- iii. When is activity conducted – April thru November, weather permitting, clients schedule times and dates with trustees
- iv. Where is activity conducted – Special Guest Farm 5248 London Lancaster Rd Groveport Oh 43125
- v. How does this further our exempt purpose - The ultimate experience of farm life and hands on experience for special children and adults. It allows them to relax, enjoy life, and forget their disabilities.

b. Petting Zoo on the road

- i. Activity – A miniature farm visit where we go to churches, schools, fairs. Animals that are taken include chickens, goat, llama, pony, rabbit, and donkey. Kids actually get to hold, pet, brush and some get to feed. This lets people know we exist and gives us a chance to promote the farm to the community and explain our purpose.
- ii. Who conducts this activity – Trustees and volunteers
- iii. When is activity conducted – April thru November, weather permitting, clients schedule times and dates with trustees
- iv. Where is activity conducted – On site of the requester at a school, church, or park
- v. How does this further our exempt purpose – This allows us to promote our farm to others and in a mini fashion to demonstrate to the special children and adults that can not get down on the farm the therapeutic effect and love that animals can bring. In nursing homes, many

patients have been brought up on a farm and this allows these people to share times in their lives. This makes them feel good inside that they can share a story or two about their lives with us. There again, it allows them to forget the pain and current problems they have. This again demonstrates the therapeutic effect and love that animals can bring.

- c. Activity on Horseback
 - i. Activity – Special need individuals come to the farm for therapeutic riding and education. They have to learn to brush the horse, saddle, lead, and ride.
 - ii. Who conducts this activity – Trustees and volunteers
 - iii. When is activity conducted – Trustees – April thru November, weather permitting, clients schedule times and dates with trustees
 - iv. Where is activity conducted – Special Guest Farm 5248 London Lancaster Rd Groveport Oh 43125
 - v. How does this further our exempt purpose – This activity really shows the client how therapeutic horses can be. Kids are tense, muscles contracted before riding begins. Touching the horse, brushing it begins the relaxation. As they ride, they relax so much that this allows the Physical Therapist to move arms and legs and stretch muscles that normally can not be stretched.
- d. 4H – Bits & Pieces
 - i. Activity – This is an outreach program of our farm. This 4H group is comprised of special needs individuals. Normally these kids would not have the opportunity to be part of an organization like this. Kids in the group have a wide range of disabilities: blindness, attention deficit, quadriplegic, and mentally delayed.
 - ii. Who conducts this activity – Trustees
 - iii. When is activity conducted – year round
 - iv. Where is activity conducted – Usually at the Columbus Public Library, could be held at participant's home or at Special Guest Farm
 - v. How does this further our exempt purpose – There again, this allows children to be part of a large organization and gives them opportunities to talk in public about their projects, be seen by others, and make friends that see them for what they are and not how they are perceived by others.
- e. Public Performances
 - i. Activity – This is show time for the kids in our program. It is a time where our kids can be proud of their accomplishments and demonstrate them to the general public. We have performed as the Champion Riders at two Franklin County Fairs and this last year at the Ohio State Fair. We demonstrated therapeutic riding, trail riding, barrel riding, and reining.
 - ii. Who conducts this activity – Trustees and volunteers
 - iii. When is activity conducted – late summer
 - iv. Where is activity conducted – Fair grounds

How does this further our exempt purpose – This demonstrates to the public our purpose and benefits of therapeutic riding. It gives us a chance to promote our program and allows others to talk one on one with us about their children and what we can do to help. It also coins an old phrase, “Seeing is believing”
