

STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS**

Houston Raiders started 2009 Summer season with 6 high school age teams. Our 18U teams competed at a very high level. Teams traveled to Phoenix Arizona; Joplin Missouri; Ft. Worth, Texas; San Antonio, Texas. 100% of our 2009 graduates received scholarship offers to play baseball at the collegiate level. Over 20 players, seniors 2009 graduates, went on to play at schools such as Texas A&M University, Northwestern State University, Sam Houston State University, Texas Christian University, Rice University, Tarelton State University, in addition to San Jacinto College, Angelina College, Texarkana College, Howard College, Navarro College and Cisco College. The Raiders also had 5 players taken in the 2009 Major League Baseball June Draft. Miguel Pena taken in the 5th round by Washington Nationals, Matt Graham taken in the 6th round by San Francisco Giants, Tyler Naquin taken in the 33rd round by the Baltimore Orioles, Zach Thomas taken in the 47th round by the San Diego Padres and Tommy Collier taken in the 48th round by the Toronto Blue Jays. Houston Raiders were Premier Baseball State Champions and NABF Regional Finalist.

The Raiders had over 100 players participate in the 2009 Summer Program. Many of the players come from low income families. Raiders are proud of the fact that many need players were able to participate because of sponsors gifts and fund raising by the Houston Raiders Staff. We look forward to upcoming seasons, and the opportunity to help kids play baseball at a competitive level. We look for our sponsor base to increase and expanding our fund-raising programs.

Our Fall Program was also a success. 5 teams participated, three 18U teams and two 16U teams. Season ran from September 2009 thru November 2009. We presently have six 2010 graduates sign early commitments to play baseball at colleges and universities. Including, Arkansas University, University of Houston, Texas Lutheran University, Texarkana College Angelina College and Seminole College. We had two 2010 graduates make the Area Code Team, one of our players was named to the Aflac-All American Team. Our fall program produced two pro prospects. We expect these players to be high draft picks in the 2010 June Major League Draft. Once again many players from low income families participated because of financial help from our sponsors.

The Houston Raiders 2010 Baseball program looks very promising. We expect over 100 players to again participate. With continued help from sponsors and an increase in funds, Raiders Baseball will help many young men play the game of baseball. In addition many of these same players will earn college baseball scholarships and get their degrees as a result.
