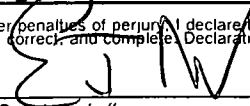
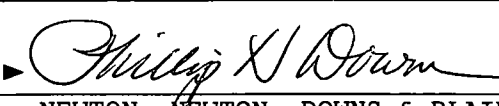

PROJECT SHALOM, A COUNSELING AND SOCIALIZATION PROGRAM SERVING ADULTS WHO SUFFER FROM CHRONIC MENTAL ILLNESS, IS THE LONGEST RUNNING PROGRAM OF JFS ALEXANDER INSTITUTE. MEDIATION MANAGEMENT AND PSYCHIATRIC COUNSELING IS OFFERED THROUGH THE PSYCHIATRIC PROGRAM OF THE FAMILIES AND CHILDREN DEPARTMENT. IN 2009, JFS OPENED A SHELTERED EMPLOYMENT THREE DAY A WEEK PROGRAM, WITH A TRANSPORTATION COMPONENT, WHICH PROVIDES WORK AND LIFE SKILLS FOR ADULTS REQUIRING A HIGHLY SUPERVISED ENVIRONMENT. JFS ALSO SPEARHEADED A COMMUNITY WIDE PROGRAM TO RAISE THE LEVEL OF SENSITIVITY TO THE NEED FOR FULL INCLUSION OF ALL INDIVIDUALS IN COMMUNAL LIFE.
