The Jackson County Youth Fair Association is a non-profit entity that is strictly operated by volunteers. We have no paid staff and are under the direction of the Board of Directors. The Board of Directors consist of individuals that may be related by marriage, siblings, etc. (Part VI, line 2)

The financial statements and Form 990 are available upon request. Financial statements are reviewed and approved at monthly board meetings. The Form 990 is prepared by a volunteer that is not the book keeper or treasurer of the association. The Form 990 is not reviewed before filed but is made available to all board members and to the public upon request. (Part VI, line 11, line 19)

In 2009, the Jackson County Youth Fair Association moved its venue to a new leased facility. A portion of the capital building and land improvements remained with the old lessor. The previous lessor was the County of Jackson, Texas (a governmental entity). The Jackson County Youth Fair Association used this facility for fifty nine years and is now leasing at a non-governmental facility. Under the terms of the old lease, all improvements incurred by the Jackson County Youth Fair Association were to remain the property of the County of Jackson, Texas. Therefore, we transferred and retired assets which were permanent effective December 31, 2009. (Schedule N, Part II)
