In 2009, PSG staff provided 20,874 services to 6,029 English speaking and 2,795 services to monolingual spanish speaking victim of domestic abuse. Services include preparing to petition for a protection orders, preparation to go through the court process without an attorney, accompaniment to hearings, preparation to petition for child custody or divorce. Assistance in accessing other community resources, safety planning, delivery of court documents to the defendant, intervention and advocacy with victim's employer -law enforcement or landlord. The agency participates in community collaboratives that include development of a domestic violence center, triage, and domestic violence task force in each county served.
