NAMI Austin also offers monthly program meetings with invited guest speakers which focus on topical information. All programs are free and open to the public. 2009 topics included: Veterans, Post Traumatic Stress Disorders, and the Latest Research on Brain Injuries; Housing: Rental Assistance, Affordable Housing, and Disability Services; The Clubhouse Model for Mental

Consumer Programs: NAMI Austin's consumer support programs provide relevant information, valuable insight, and the opportunity to engage in support networks. These programs draw on the lived experience of mental health consumers who have learned to live well with their illnesses and have been extensively trained to help others. In Our Own Voice (IOOV), is a speakers bureau composed of trained consumers living with mental illness who make presentations to community groups. These presentations educate the public and support consumer recovery and empowerment while dispelling the stigma of mental illness. IOOV presenters receive a stipend from NAMI Austin for each presentation made. In 2009, NAMI Austin began a new project - to create a Clubhouse for mental health consumers under the guidance of the
