The Rafiki Foundation is a Chrstian organization whose goal is to help Africas orphaned and vulnerable children become godly contributors to their communities and the world Rafiki Villages are now operational in Ghana, Kenya, Liberia, Malawi, Nigerna, Rwanda, Tanzania, Uganda & Zambia The ChildCare Program is designed to provide completely for the physical, educational, vocational, and spiritual needs of several hundred children The ChildCare Program provides schools, dining facilities, an infirmary, a playing field, agricultural land, twelve cottages, and four residence halls Each cottage houses ten children and one African mother In addition, there are four residence halls which provide housing accommodations for our children as they enter secondary school The mothers and residence hall parents receive training on child development and Christian principles to provide a loving home for each child Each cottage lives together as a familyeating, going to church, playing, and working together The children and the mothers connect as family When the children enter junior secondary school they move to a residence hall at the Rafiki Village which has a married couple who become the Rafiki mother and father for the children thus providing a father figure for our Rafiki children Each Village includes an accredited school for pre-k thru 12th grade within the Education Program that provides quality education for the children who live at the Village Instruction in cultural arts and athletics are also available to the children The Rafiki Medical Program provides on-going care for those in the Village, and is periodically open to the local community for week long clinics as medical personnel are available Developing countries have very few, if any, resources to give public health aid to their citizens, many of whom have little access to routine medical care The intention of the Rafiki Foundation is to minister not just to those who live on Village grounds but also to the surrounding communities With the village concept, we provide a desperately needed center of hope and help in areas of extreme poverty By focusing our efforts on the children and youth of Africa, we hope to change the lives of those who will have the greatest impact on the future of their countries
