(2) Resale of pieces from the WORKING series and previous projects to a variety of outlets.

(3) Continuing research and writing on a book by poet Jim Schley, with Homelands serving as a fiscal agent.

(4) Design, planning and fundraising for a new project, about hunger, in collaboration with NPR, two universities and a photo agency.
