Briefly describe the organization's mission

Chisholm Trail Communities Foundation (CTCF) is a tax exempt, non-profit, publicly supported, philanthropic institution with the long term goal of building permanent, named funds for the broad-based charitable benefit of the local residents. The mission of CTCF is to enhance the quality of life in the local area. CTCF carries out this very broad mission by building restricted funds and using the annual income to support a variety of local nonprofit organizations through grants and special projects. CTCF's assets are held in separate funds established by local individuals, families, businesses, and charitable institutions. Each fund may have a special purpose, but the foundation board of directors, representing the community, oversees them all. The IRS recognizes CTCF as a public charity in part because they receive support from the general public and their board broadly represents the area served.

Earlier events are lectures and workshops on the artist and his music and times. The artistic director is a local professor emeritus with a national reputation for academic excellence.

Back pack buddies began as a start of school back pack of school supplies for underprivileged children. It became not only that start of school back pack but then a weekly bag of food for the children on supplemental meals at school. The number of children served increase every year. Children qualify by the school if they are on subsidized meals at school. Bags are packed by groups from community churches and distributed by the schools to protect recipients' identities.

The child-care initiative recognized a need for more high quality day care in the community. Plans are to start (in 2011) a teaching day care center, offering day care but also education in best practices in day cares from throughout the country.
