Texas New Media Association, EIN 74-30044446, has operated as austinyouth.org (AYO) for eight years, specifically to provide media training for at risk youth in the Austin, Texas, area that could be applied in a career setting. Seeking to expand the mission of AYO, the Board approached Shannon Hopkins to hire her as Executive Director and to use her expertise to add the development of global social enterprise and social justice program services to the local media education program services of AYO.

Currently, upon Ms. Hopkins recommendation, the Board has voted to change the name of Texas New Media Association to Matryoshka Haus, and is supporting Ms. Hopkins in her initial development of Sweet Notions, a social enterprise model.

Matryoshka Haus is an organization that encourages the development of social enterprises and social justice and human rights campaigns and projects. Its goal is to launch ever bigger pebbles into the traditional business as usual pool.
