Our program meets the community needs by providing food, clothes, personal care items, and assistance where needed. By doing this we are strengthening our educational program as we stress to the children and youth the importance of helping others.

Our organization is partnered with 27 facilities throughout Central Florida to work with needy children, teens, and the elderly. In the summer, we assist in all areas of promoting volunteerism. Our time frame is ongoing (January – December) and our student summer program is May-August. The summer focus is to organize volunteer projects and activities for students.

Throughout the year, we have fundraisers to raise money to buy the things needed at the facilities we are partnered with.
