STATEMENT 1

PROGRAM DESCRIPTION

In 2009 The Call Academy (DBA Open Roads) ran a month-long educational summer program for between 12 and 20 low-income high school students from around the United States. This educational enrichment program was free-of-charge for the students, and taught essential leadership and communication skills through a combination of the teaching of documentary photography, digital video, oral presentation skills, and through an immersion in team building activities in the outdoors.

The 2009 programs traveled throughout the Northwestern United States, and culminated in a public exhibition of the students' original documentary projects at the Seattle Art Museum. In addition, Open Roads provides its graduates with ongoing support throughout the school year in the form of academic advising and the delivery of cameras to their schools so that they could teach others what they had learned over the summer.
