

Administer, continue to develop, and program events for Public Space One, a volunteer-run art, culture, and performance venue providing opportunities for local visual and performance artists. Renovated and opened another room for use as an art exhibition space. Hosted ten, month-long exhibitions from local and nationally working artists.

Provided fiscal sponsorship to the Mission Creek music festival in its third year. Mission Creek is an annual celebration that takes place in the venues and art spaces of downtown Iowa City, providing an easily navigated nexus of music, literature, and visual art. The festival, which has brought over 50 well known national acts to Iowa City and paired them with local musicians for the vents, aims to cater to a demographic different than other festivals in Iowa City, namely young professionals, recent transplants, and citizens looking for something other than mainstream festivals like the Jazz and Art Fests.
