The System maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges foregone for services and supplies furnished under its charity care policy, the estimated cost of those services and supplies, and equivalent service statistics. Additionally, the System foregoes charges related to Medicare, Medicaid, and other third-party payors. Including bad debts and uncollected accounts, the total amount of uncompensated care was \$67,406,454 and \$59,186,059 in 2009 and 2008, respectively. The System is subject to the Texas Charity Care Act which requires it to provide certain levels of charity care to qualifying patients. It is possible to satisfy the requirements of the Act by providing various levels of charity care depending on the particular situation of the System. The Act also contains a number of exceptions and makeup provisions. Management is of the opinion that it is in material compliance with the terms of the Act.

The licensed hospital facility listed in Part V is the sole health care facility of the organization.

2 Needs assessment. Describe how the organization assesses the health care needs of the communities it serves.

HCM assesses the needs of the community through patient surveys. Patients receiving care in the following service lines are randomly surveyed by Press Ganey, an independent hospital auditing firm which audits 1800 hospitals in the United States. In-patient care, Out-patient care, ER, and Home Health. The following service lines are surveyed in an HCM paper-generated survey disseminated at the point of dismissal: HCM Breast Center, HCM Community Clinic, and HCM Sleep Lab. The HCM Community Clinic serves the indigent population and the surveys are a key contributor in determining if indigent community needs are being met.

3 Patient education of eligibility for assistance. Describe how the organization informs and educates patients and persons who may be billed for patient care about their eligibility for assistance under federal, state, or local government programs or under the organization's charity care policy.

HCM patients speak with an HCM Business Office representative before care to determine if they are eligible for assistance under the federal, state and local government programs or the organization's charity care policy. The patient's eligibility is assessed and carefully managed, so that if he/she overpays, he/she is reimbursed the reconciling amount.

4 Community information. Describe the community the organization serves, taking into account the geographic area and demographic constituents it serves

The organization serves eight counties in the Hill Country Gillespie, Blanco, Burnet, Kendall, Kerr, McCollough, Mason and Llano. The primary service area of Gillespie County (pop 24,299) accounts for about 50% of HCM patients. The total service area population is 184,792, and the average patient age is 65 years old.

5 Community building activities. Describe how the organization's community building activities, as reported in Part II, promote the health of the communities the organization serves

HCM embarked on a project to build a health and wellness community center in 2009. Collaborating with the City of Fredericksburg, physicians and the Fredericksburg Chamber of Commerce, HCM funded the creation of an architectural plan for the center.

The organization furthers its exempt purpose through up to 40 public health events and screenings a year which are advertised and well attended. The HCM Wellness Center offers remote immunization "drive-thrus" to increase immunization volumes. Employees devote time and money to the Community Needs Council to furnish school supplies to eligible children, to the Area Food Bank for the hungry, and to the local Boys and Girls Club for community children activities. The Auxiliary, hospital volunteer organization, raises funds to further employee health care education, which nurtures the available workforce. The organization has the largest volunteer base in Fredericksburg. Also, funds were donated to Relay for Life, Health Occupation Student Association (HOSA), and Eishbahn. Employees also served in leadership roles for community organizations. HCM also collaborates with city and county officials to prepare for emergency scenarios. HCM invites city and county emergency officials to participate in mock emergency situations to prepare for an actual, likely emergency based on the geographical proximity of the hospital, such as a tornado or major chemical spill.
