

The primary service area of Gillespie County (pop. 24,299) accounts for about 50% of HCM patients. The total service area population is 184,792, and the average patient age is 65 years old.

- HCM embarked on a project to build a health and wellness community center in 2009. Collaborating with the City of Fredericksburg, physicians and the Fredericksburg Chamber of Commerce, HCM funded the creation of an architectural plan for the center.

- 6 Provide any other information important to describing how the organization's hospitals or other health care facilities further its exempt purpose by promoting the health of the community (e.g., open medical staff, community board, use of surplus funds, etc.) The organization furthers its exempt purpose through up to 40 public health events and screenings a year which are advertised and well attended. The HCM Wellness Center offers remote immunization "drive-thrus" to increase immunization volumes. Employees devote time and money to the Community Needs Council to furnish school supplies to eligible children, to the Area Food Bank for the hungry, and to the local Boys and Girls Club for community children activities. The Auxiliary, hospital volunteer organization, raises funds to further employee health care education, which nurtures the available workforce. The organization has the largest volunteer base in Fredericksburg. Also, funds were donated to Relay for Life, Health Occupation Student Association (HOSA), and Eishbahn. Employees also served in leadership roles for community organizations. HCM also collaborates with city and county officials to prepare for emergency scenarios. HCM invites city and county emergency officials to participate in mock emergency situations to prepare for an actual, likely emergency based on the geographical proximity of the hospital, such as a tornado or major chemical spill.
