The CEC’s Food Pantry provides groceries to over 10,000 low-income people living in northeast Tarrant County each year. In addition to food, the pantry runs community building programs for seniors and for single-parent families. Living in isolation is a major issue for both seniors and single parents. The CEC’s programs help connect the participants with each other and with resources available to them in the community. On average 50-60 seniors attend each week while the monthly Single Parent Family Network has between 25-100 single parents attending.

The CEC’s Adopt-A-Family Program helps homeless families become economically self-sufficient. The CEC owns 64 single-family houses and 16 townhouses located in Fort Worth, Arlington, and northeast Tarrant County. In 2009, the CEC housed 106 homeless families.

The CEC’s Affordable Housing Program provides housing for people who otherwise would have trouble leasing a home in Tarrant County. Between 20-50 housing units are used for this program. Rents from the affordable housing units partially offset the housing costs for the Adopt-A-Family and Open Arms Programs.
