With a three year seed grant from the Robert Wood Johnson Foundation, AIDS Arms was
organized in 1986 under the leadership of the Community Council of Greater Dallas as
grassroot efforts to provide case management to HIV/AIDS patients. In 1989 it became an independent
501(C)3 and in 1990 was approved as a United Way of Metropolitan Dallas funded agency. From
its grassroots with six committed individuals, in 2009, AIDS Arms had 82 full time employees,
including 21 case management staff. The case management employees provide a range of client
centered services that link clients with healthcare, psychosocial, and other services that
reduce barriers to care and assist clients in obtaining adherence to their lifelong medical
care and treatment regimens. Each case manager carries an average caseload of 65 clients. Their interventions

AIDS Arms provides comprehensive HIV outpatient medical care at Peabody Health Center
(PHC) located in South Dallas. The PHC opened in 2001 with fewer than 200 patients.
In 2009, it served 976 patients with 6,428 medical visits. PHC employs three
full time physicians, three nurse practitioners, three registered nurses, and seven support staff.

4c (Code _____) (Expenses \$ 736,107. including grants of \$ 0.) (Revenue \$ 728,169.)Prevention Services

The prevention services are fully integrated in the Agency's comprehensive continuum of care and focuses on risk reduction efforts
with both HIV+ and at risk HIV- individuals. It comprises two major grants. The INSPIRE project is funded by SAMHSA to prevent
and reduce onset of substance abuse, hepatitis and transmission of HIV. Staff of the project provide outreach and prevention
education at venues where HIV+ or at risk individuals congregate or receive services. In 2009, INSPIRE provided services to 8,071
high risk individuals and tracked 100 participants in the project. In 2007, the Department of State Health Services (DSHS)
awarded AIDS Arms a multi-year grant to provide evidence-based risk reduction intervention and HIV/STD testing for high
risk individuals. This grant has three levels of programming: (1) Comprehensive Risk Counseling Services (CRCS)
focuses on clients with multiple risky behaviors; in 2009, CRCS achieved the following programmatic result: 287
individuals were reached through outreach activities, and 496 CRCS-sessions were completed; (2) Protocol-Based Counseling
