TCHC LEADS THE YEAR-ROUND PLANNING ACTIVITIES INCLUDING OVER 110 MEETINGS OF ITS MEMBERS, COMMITTEES AND TASK FORCES TO PLAN, TRAIN, REVIEW AND MONITOR THE EFFECTIVE DELIVERY OF SERVICES TO THE OVER 5,000 PERSONS PER YEAR THAT WILL EXPERIENCE HOMELESSNESS IN THE COMMUNITY.

TCHC MANAGES THE HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS) THAT IS THE DATABASE OF HOMELESS PERSONS AND FORMERLY HOMELESS PERSONS BEING SERVED BY NON-PROFITS OR RECEIVING FEDERAL MCKINNEY-VENTO FUNDED HOUSING OR SERVICES.

TCHC ANNUALLY SUBMITS FOR THE COC THE CONTINUUM OF CARE HOMELESS ASSISTANCE GRANT TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT THAT PROVIDES OVER \$9 MILLION IN GRANT DOLLARS FOR HOUSING AND SERVICES FOR THE HOMELESS. TCHC DOES NOT RECEIVE ANY DIRECT FUNDS FROM HUD, BUT SERVES AS THE COLLABORATIVE APPLICANT FOR THE COMMUNITY.

TCHC IS RESPONSIBLE FOR CONDUCTING A BIENNIAL CENSUS OF THE HOMELESS FOR THE COC. TCHC PROVIDES STATISTICAL INFORMATION ON THE SCOPE, DEMOGRAPHICS AND TRENDS OF HOMELESSNESS IN THE COMMUNITY.
