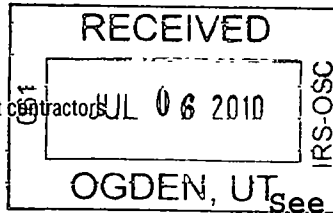

Exchanged Life Ministries Texas offers counseling services from the perspective of the victorious Christian life. One Hundred Two (102) individuals were counseled for a total of 1,090 counseling hours. The donations received for this program totaled \$35,357.
