MDHA OPERATES THE BRIDGE HOMELESS ASSISTANCE CENTER ("BRIDGE") UNDER A MANAGEMENT SERVICES CONTRACT WITH THE CITY OF DALLAS. THE BRIDGE, WHICH OPENED IN MAY 2008, PROVIDES CARE AND HOUSING, MEALS, SECURITY AND FACILITIES TO APPROXIMATELY 1400 HOMELESS PEOPLE PER DAY. MDHA CONVENES THE CONTINUUM OF CARE HOMELESS ASSISTANCE PROCESS FOR DALLAS AND COLLIN COUNTIES, WHICH FUNDS NEARLY \$14 MILLION IN TRANSITIONAL HOUSING AND PERMANENT SUPPORTIVE HOUSING ANNUALLY. THE PROCESS, WHICH IS PART OF THE HUD SUPER NOFA, INVOLVES SERVICE COORDINATION, PROJECT MONITORING AND TECHNICAL ASSISTANCE TO HUD-FUNDED AND NON-HUD-FUNDED AGENCIES. THE MDHA CONTINUUM OF CARE COORDINATED TO PROVIDE SERVICES TO THE HOMELESS COMMUNITY, INCLUDING CONDUCTING THE ANNUAL HOMELESS ASSISTANCE PROCESS FOR DALLAS AND COLLIN COUNTIES, WHICH IS USED BY PRIVATE AND GOVERNMENT SOURCES LOCALLY AND NATIONALLY FOR FUNDRAISING, RESEARCH AND NEEDS ASSESSMENTS.
