	United Regional Health Care Foundation was organized in 1998 in support of United Regional Health Care System's commitment to providing excellence in health care for the communities we serve. As the only full service hospital in the region, United Regional is the single source for trauma care and comprehensive emergency services in Wichita County and the surrounding eight counties. United Regional Health Care Foundation is a Type I supporting organization under the Internal Revenue Code Section 509(a)(3). The Foundation organized a number of fundraising and educational activities in 2009 for the following purposes at United Regional: Annual Giving; Heart of a Woman, an event organized to help women understand the risks they face from heart disease, funds heart health education and improvements to United Regional's Cardiac Institute. This event has grown to over 600 attendees, includes health education and wellness tips, and provides free wellness screenings for more than 400 annually. The 2009 United Regional Health Care Foundation Golf Classic was a sell-out event in support of an orthopedic surgery suite in the Bridwell Tower at United Regional. Children's Miracle Network assists United Regional in providing state-of-the-art technology and care for infants and children treated in a wide range of departments at United Regional. A number of activities and special events help ensure the best in health care and safety for children, and contribute to the total raised each year. Car seat safety checks are provided in cooperation with emergency personnel and local sponsors. Fundraising and awareness events are Ranch Days, Miracle Pennies school projects, and the Credit Unions for Kids Golf Scramble. The 2009-2010 Spirit of Giving Campaign raised significant funds from United Regional's 1,820 employees for Children's Miracle Network, the Chapel Renovation, United Regional's Friendship Fund, Rathgeber Hospitality House, and United Way. United Regional Foundation distributes funds raised to United Regional Health Care System as projects are completed, equipment is purchased, and pledges are collected. In 2009 the Foundation distributed a total of \$7,730,404 to United Regional from funds raised in 2009 and in prior years for building and facility improvements, Children's Miracle Network-sponsored equipment and programs, and other special projects.
