Established in 1997, Medical Bridges, Inc. (Medical Bridges) is dedicated procuring medical and surgical supplies and equipment for donation to qualified providers of healthcare to indigent populations in medically underserved countries. Medical Bridges procures donations of surplus supplies and equipment from hospitals, clinics, private practice physicians, medical supply companies, home health agencies, and private individuals. In 2009, Medical Bridges prepared and sent shipments to 35 countries. These shipments ranged in size from suitcases filled with sutures to 40-foot ocean-freight containers holding up to 800 boxes of supplies and equipment. Medical Bridges diligently assesses the multitude of requests received annually to ensure that consignees meet requirements both in terms of who receives the supplies and how the supplies are distributed to the community. Medical Bridges relies greatly on the expertise and time commitment of volunteers. Volunteers work in the distribution center and on special projects throughout the year; they routinely log in more than 7,500 hours each year.
